



**1st Central European TOYOTA Employees Championships
8th Polish TOYOTA Employees Championships
in Half Marathon and Run for Health**

Participants of the Central European TOYOTA Employees Championships and the Polish TOYOTA Employees Championships in the Half Marathon and Run for Health are subject to the Rules and Regulations of the **25th TOYOTA ECO Half Marathon Wałbrzych (25. TOYOTA EKO Półmaraton Wałbrzych).**

I. PURPOSE

1. To promote running among TOYOTA employees as the simplest form of physical activity.
2. To foster integration among employees.
3. To select the Central European and Polish Champions (both male and female) among TOYOTA employees in the Half Marathon and Run for Health.

IV. DATE

August 24, 2025. The Half Marathon and the Run for Health, including the 1st Central European TOYOTA Employees Championships and the 8th Polish TOYOTA Employees Championships, will start at 10:00 AM.

V. REGISTRATION

1. The Championships are open to employees of TOYOTA and LEXUS plants, logistics, finance, and sales units. Only Polish citizens employed by TOYOTA and LEXUS will be classified in the Polish Championships.
2. Employees of Toyota Motor Manufacturing Poland – the sponsor of the grand prize in the lottery (Toyota Aygo X) – are exempt from the entry fee.
3. Employees of other TOYOTA and LEXUS units are entitled to a 50% discount on the regular entry fee, depending on the registration date. Fee details are available in the Rules of the 25th TOYOTA ECO Half Marathon Wałbrzych.
4. Registration is done via the form available on the official website: www.polmaraton.walbrzych.pl. In the "Toyota Employees Classification" section, choose: "Yes, I am a Toyota employee."
5. On the day before and the day of the event, registration and race packet pick-up are available at the Race Office (Stara Kopalnia, ul. Piotra Wysockiego 29, 58-304 Wałbrzych). The office will be open:
 - Saturday, August 23, 2025 – from 2:00 PM to 8:00 PM
 - Sunday, August 24, 2025 – from 7:00 AM to 9:00 AM
6. All participants must confirm their eligibility by presenting an employee card or an employer-issued employment certificate when collecting their race packet.
7. **IMPORTANT!** Failure to present the above-mentioned documents will result in the participant being transferred to the general category and required to pay the applicable fee difference at the Race Office.
8. Registration constitutes acceptance of these Regulations and the Regulations of the 25th TOYOTA ECO Half Marathon Wałbrzych. It also implies consent for personal data processing for the purposes of the event.

VI. CLASSIFICATION AND AWARDS

1. General classification includes two categories: men and women.
2. In both the Half Marathon and Run for Health, the top three finishers in each category (men and women) will receive trophies – separately for the Central European and Polish Championships.
3. Only Polish citizens will be classified in the Polish TOYOTA Employees Championships.
4. All participants will receive commemorative medals.

VII. FINAL PROVISIONS

1. Results will be available:
 - a) For everyone after the race on www.polmaraton.walbrzych.pl and on the website of the timekeeping company.
 - b) Via SMS for participants who provided a phone number during registration.
2. Medical care will be provided on the course and at the start/finish.
3. Each participant is insured against accidents up to PLN 5,000.
4. Participants who do not finish within the time limit will not be classified and will be excluded from the prize lottery.
5. Cloakroom and toilets will be available.
6. Each participant will receive a race bib, which must be worn visibly on the chest.
7. Covering or obscuring the race bib, or shortening the route, will result in disqualification.
8. Random anti-doping tests will be conducted (2 athletes from the general classification).
9. Only verified participants with race bibs may be on the course. External assistance (e.g., pacing, pulling) will result in disqualification.
10. Water and isotonic drinks will be available on the course and at the finish. A hot meal will be served post-race.
11. There will be at least two refreshment points on each lap, and water misting tents in case of hot weather.
12. The event will take place regardless of weather conditions.
13. Organizers are not responsible for lost items.
14. Participants are responsible for bringing their own personal protective equipment.
15. The organizer reserves the right to amend the Regulations. Changes will be announced at www.polmaraton.walbrzych.pl.
16. Protests (including those affecting participants' rights or obligations) must be submitted to the Race Office by 2:00 PM on August 24, 2025. They will be reviewed within 48 hours. A protest fee of PLN 500 applies.
17. Final interpretation of the Regulations lies with the Organizer.
18. The Organizer reserves the right to change the event date or cancel the race due to force majeure, as declared by competent authorities.
19. The Organizer may limit the number of participants due to restrictions on mass events. Participation will be granted in order of paid registrations.
20. Matters not covered by these Regulations are decided by the Organizer.
